

Vassar Township Parks and Recs Meeting

August 3rd, 2022

Meeting called to order at 7:00pm.

J.Zawol motions to accept July 5th meeting minutes with corrections by changing "except" to accept, and "august" to August. D.Foether seconds. All in favor, motion carries.

D.Foether presentation and discussion on a packet she put together containing a survey for Township residents to voice their opinions on some park related events and additions that the Committee might take into consideration.

R.Fall motions to accept the proposal for the Township Park survey being mailed and posted online for the current cost of postage, approximately \$1040.00 using the Parks and Recs budget. S.Tester seconds. All in favor, motion carries.

T.Eurich motions to get quotes for the cost and installation of underground wiring from the meter base to the shed, a 200 amp box for inside the shed, 4 double electrical outlets for inside the shed, underground wiring from the shed to the pavilion, 6 double outlets 4ft from the

ground in the pavilion, and 6 double outlets along the header board near the ceiling of the pavilion. R.Fall seconds. All in favor, motion carries.

R.Fall has started construction on a one lane horseshoe pit, he has supplied sand and woodchips which he has started spreading around the area. We will only have one lane at this time with the possibility of expansion at a later date.

D.Foether motions to get quotes for material and installation cost for approximately 200 ft of 6inch drainage tile and 2 catch basins to help prevent flooding with response by August 31st, 2022. S.Tester seconds. All in favor, motion carries.

Committee discussion on playground equipment, agreement on D.Foether researching price and availability of Playground Inspector through LARA, tabling the climbing wall until a later time, and T.Eurich to get quotes on different child swings and a gravity diamond play area from Miracle playground equipment to add to the parks playground.

R.Fall will work on getting a quotes for cost and delivery of 10 tons of processed road gravel for the parking lot and will be presented to the Board of Trustees for approval. Also asking for approximately \$200.00 for 3 posts and 4 rails to construct the corner fence located on the Southeast corner of the park property.


Committee agrees to table the tractor discussion until next meeting.
