B.Foether motions to approve January 10<sup>th</sup> Meeting Minutes with corrections, B.Partridge seconds. All in favor, 5- yes, 0- no. Motion carries.

B.Partridge motions to have T.Borcharding do payables, motion dies for no second.

T.Borcharding motions to approve payables, J.Stack seconds. All in favor, 5-yes, 0-no. Motion carries.

B.Foether motions to pay \$239.99 for a new chair for the Township Clerk from supplier and to be put on March payables, T.Borcharding seconds. All in favor, 5- yes, 0-no. Motion carries.

Correspondence from the University of Michigan Dearborn E-Cities gave the Township a Good Rating.

Inquire on when the Townships contract with Republic is up.

B.Foether abstains discussion about the Fire Run.

B.Partridge motions to postpone discussion until next months meeting and to ask Administrative Assistant to get more information and question " bonfire not being attended "and clarify fire in the woods or not, and if there was snow on the ground, D.Pounds seconds. 4- yes, 0- no, 1- abstains. Motion carries.

B.Foether motions to pay with check the credit union balance on the 2<sup>nd</sup> day of the month, when statement is received, T.Borcherding seconds. 4- yes, 1- no. Motion carries. This Motion supersedes the Motion set on January 10<sup>th</sup>.

Board discussion on whether or not the Marijuana Coordinator should be a full time dedicated job position.

Resident on Dubois RD wants to be hooked up to city sewer, have to contact the City Manager to find out what the rules are regarding sewer hookup.

B.Foether to hold a special meeting to discuss changes to the blueprints for the new hall, an addition of a 6' 5" room for the Deputy so there is a place to do paperwork.

B.Partridge motions to authorize Parks and Recs to go after community grant, T.Borcherding seconds. All in favor, 5- yes, 0- no. Motion carries.


Need to discuss with Troy Eurich the numbers on the playground equipment. An itemized bill from the Parks and Rec on what they are planning on spending this upcoming year.
