Budget: We have approximately \$7000.00 left in the budget. Port-a-johns cost \$440.00, \$900.00 was spent for the Easter event.

Redoing the park parking lot with the same crushed asphalt as the hall parking lot. One of the trails has to be ada compliant as is stated in our master plan. We can use reject crushed asphalt or granite for that. The playground needs to be inspected every 3 years so will need to find someone that does that. We also must have an abuse and molestation policy in place. Janice is going to check with the port-a-john company to see if the contract needs to be renewed every year.

Events 26-27: Most will stay the same but be thinking about new ideas and costs for future events. Have for April meeting if possible. The Trivia night event raised a total of \$219.00. The event itself raised \$124.00 the silent auction brought in \$95. One of the upcoming teen will be a trivia night. Easter and Mommy & Me flyers were handed out to be distributed. Daryse will be submitting a detailed budget report to the planning commission for the Mommy & Me mother's day event. Daryse made a motion to request \$128.00 for canava, brushes, and paint 2nd by Cheryl. Ayes-5, Nays-0, Absent-2. All in favor. Motion carried.

Park Clean-up Day: April 25th meet at park at 9:00am. Alternate date is May 16th 9:00am.


Public Comment: Bob Reil has concerns that we are not bringing in enough money to
